DECISION ON THE OBJECTION BY SAVE LAMU NATURAL JUSTICE TO THE ISSUANCE OF AN ELECTRIC POWER GENERATION LICENCE TO AMU POWER COMPANY LIMITED

PURSUANT to the provisions of section 28 (4), (5) and (6) of the Energy Act, the Energy Regulatory Commission notifies the general public that it has received an objection from Save Lamu Natural Justice to the issuance of an electric generation licence to Amu Power Company Limited. The Commission heard the objection on 6th December, 2016 in Lamu in and after reviewing the views of stakeholders orders that:

1. Environmental concerns

- (i) The project affected persons (PAPs) did not object to the power plant being licensed. Their only concern was a fair relocation and compensation which is being undertaken by the Government in liaison with the PAPs.
- (ii) All environmental issues were addressed in the Environmental Social Impact Assessment (issued by the National Environment and Management Authority) and effective mitigation measures proposed. When implemented, the concerns of the objector will be addressed.

2. Technical issues

- (i) The concern on the demand has been addressed by the Government in the Least Cost Power Development Plan (LCPDP) and by the developer through the identified technology of the plant.

- (ii) There is need for the country to diversify its sources of energy in order to have energy security and competitive energy prices.
- (iii) The location of the plant is appropriate. The power plant will supply the Coast region with sufficient power and it will minimise the cost of transmission and significantly lower technical losses.
3. Economic issues
- (i) The fuel price has been addressed in the power purchase agreement and the issue of livelihoods of the people of Lamu has been addressed in the environmental social impact assessment.
- (ii) The cost of the project will be recovered through the tariff as contained in the power purchase agreement.

Taking the above reasons into account, the Commission disallowed the objection. The above decision is based on the objects and mandate of the Commission envisaged under section 5 (a) and powers under section 6 (c) and (e).

- Accurate estimation of the dimensions and quantities of materials required.
 - Use of durable, long-lasting materials that will not need to be replaced as often, thereby reducing the amount of construction waste generated over time.
 - Provide facilities for proper handling and storage of construction materials to reduce the amount of waste caused by damage.
 - Use building materials that have minimal or no packaging to avoid the generation of excessive packaging waste.
 - Reuse packaging materials such as Removed wooden poles, cartons, cement bags, empty metal and plastic containers to reduce waste at site.
 - Waste collection bins to be provided at designated points on site.

 - Building a storage pit which can be filled with freshwater before commencement of the project, which can act as an available reserve to minimize possible over abstraction with the local supply.
 - Drilling a bore hole to tap in to aquifer of Vumbe wells in the mainland.
 - Locating a local source that is acceptable with the local community.
 - Treating sea water through a reverse osmosis process.

Waste water

- Wastewater can be recycled and used in the drilling process, domestic effluent can also be treated and recycled and sludge from site for safe disposal at a designated disposal site.
- Where possible rain water can be used in the drilling process. If pit water is deemed uncontaminated it can be pumped offsite or reused as irrigation water for restoration of the site perimeters.

**IMPORTANT NOTICE TO SUBSCRIBERS TO
THE KENYA GAZETTE**

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplement*, etc.:

- (1) *The Kenya Gazette* contains Notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government. Because of this, they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the Notice is, each page being numbered and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition. of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
